NOTIFICATION

No. 6/22/2016-6HG1/12-70096/1 , Whereas, preliminary notification no. 6/22/2016-6HG1/1041712/1, dated 10.08.2017 was issued under Section 11 of "*The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013*" for acquisition of land connecting area for the public purpose namely **"For Construction of 200 feet wide Master Plan Road P.R. 7 in New Chandigarh and SAS Nagar.** This Notification was published in the Punjab Government Gazette dated 10.08.2017 and in the two daily newspapers "The Tribune" (English version) dated 19.08.2017 and "Rozana Ajit" (Punjabi version) dated 19.08.2017 The Public Notice regarding the substance of this notification in local language (Punjabi) was got published in the locality as per Rapat no. 1 (Village Husainpur and Thaska 1, dated 01.09.2017), of the Roznamcha Waqati of the Patwar Circle, in the office of, Tehsil Kharar and S.A.S. Nagar and District Collector, S.A.S. Nagar. This notification was also uploaded on the website on 17.08.2017 of GMADA, S.A.S. Nagar.

Whereas, Governor of Punjab is satisfied that the land specified below is needed by the Government at public expense for public purpose, namely **"For Construction of 200 feet wide Master Plan Road P.R. 7 in New Chandigarh and SAS Nagar** in accordance with the duly notified Master Plan of S.A.S. Nagar revised Master Plan approved drawing No. 2252/15/D.T.P.(s) dated:28-12-2015 in the area of Tehsil Kharar, District S.A.S. Nagar. In this connection, based on the census survey of affected families, a Rehabilitation and Resettlement Scheme of the main area of this land was prepared as per provisions of Section 16 of the said Act, by the Sub Divisional Magistrate Kharar-cum Administrator, Rehabilitation which has been reviewed by the Collector. The affected families of these villages will be also covered as per guidelines exists in the main scheme. Thereafter, approval of the Commissioner Rehabilitation and Resettlement Roopnagar as per provisions of Section 17 of the Act. was received.

This declaration is made under the provisions of Section 19 of "*The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013*" to all whom it may concern and under the provisions of Section 21 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Land Acquisition Collector, Urban

Development, PUDA Bhawan, Sector 62, SAS Nagar is hereby directed to take possession of the said land.

Village Husainpur and Thaska, Tehsil Mohali, District SAS Nagar is hereby declared as "Resettlement area" for this project.

Plan of the land may be inspected in the offices of Land Acquisition Collector, Urban Development, PUDA Bhawan Sector 62, S.A.S. Nagar.

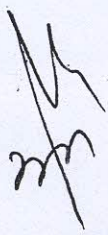

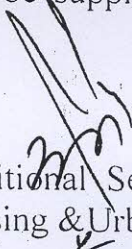

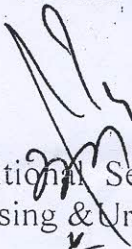
