In pursuance to the decision of the Punjab Regional and Town Planning and Development Board's meeting held on 17.12.2019, a public notice was given on 04.02.2020, inviting objections/suggestions from the general public for change of landuse of villages Birindpur, Dhudianwala, Hussainpur, Saido Bholana and Lodhi Bholana opposite Rail Coach Factory, from 'Agriculture Zone' to 'Residential Zone' upto the extent of 500 mts beyond mixed landuse zone.

No objection/suggestion was received. The issue was discussed in the 40th meeting of the Board held on 23.10.2020. The Board approved the proposal without any change.

Accordingly, the amendment in Master Plan Kapurthala is hereby notified u/s 70(5) of The Punjab Regional and Town Planning and Development Act, 1995, as depicted in drawing no. D.D.T.P (K) 10/2011 dated 14/10/2011 revised on 06/10/2020.
