No. 1/3/2021-2HG1/552 With evolving technologies and accelerating pace of urban development, the administrative restructuring of the Department has been felt necessary to segregate Developmental and Regulatory roles within the department and to bring Planning, Licensing, Regulatory and Enforcement under one umbrella. The Governor of Punjab is pleased to order with immediate effect the re-organization of the Directorate of Town & Country Planning as below:-

- (1) The re-organization shall comprise of abolishing 101 posts of different cadres and creating 175 new posts. The total existing sanctioned staff strength of the department on restructuring shall be as outlined at Annexure-I enclosed, who shall be under the administrative control of Director, Town & Country Planning and their salary shall be drawn from Government Treasury as per the budgetary allocation as approved by Finance Department from time to time. The salary of the staff, posted in PUDA from Directorate of Town & Country Planning, shall be drawn from the Punjab Urban Planning and Development Authority (PUDA), S.A.S. Nagar.
- (2) There shall be a separate position of Director, Town and Country Planning, Punjab who shall be the In-charge of the Planning along with Licensing, Regulatory and Enforcement functions in the State.
- (3) The Director, Town and Country Planning, Punjab may delegate some powers to the concerned Chief Administrators of the Urban Development Authorities for efficient functioning particularly for regulatory works at local levels for time being.
- (4) The Director, Town and Country Planning, Punjab shall be supported by two Chief Town Planners. One post of Chief Town Planner, Punjab mainly for Planning, Licensing, Technical approval, Administrative work, etc for State of Punjab and other post of Chief Town Planner(PUDA) at the Punjab Urban Planning and Development Authority (PUDA), S.A.S.Nagar, mainly for Regulatory and Enforcement work.
- (5) The reorganized structure shall have a State Headquarter, namely, Director, Town and Country Planning, Punjab, with the following staff:-

The office of Senior Town Planner (PBIP) at Bureau of Investment Promotion (Invest Punjab) shall comprise the following technical staff along with a Senior Scale Stenographer from Directorate of Town & Country Planning, (whose salaries shall be drawn from State Headquarter):-
