No. Whereas in order to develop Dasuya town and its surroundings in an orderly manner, and to prepare Master Plan under "The Punjab Regional and Town Planning and Development Act, 1995, Local Planning Area, Dasuya was declared vide Notification No. 12/6/2010-4HG1/1934, dated 21.06.2010 under section 56 (1) of the said act.

Whereas Chief Town Planner, Punjab, was declared as Planning Agency for aforesaid Local Planning Area under section 57 of "The Punjab Regional and Town Planning and Development act 1995" vide notification No. 12/6/2010-4HG1/1940, dated 21.6.2010.

Whereas Planning Agency prepared the Master Plan for Local Planning Area Dasuya and published the same in newspaper on 08.12.2015 under Section 70 (3) of "The Punjab Regional and Town Planning and Development Act, 1995", for inviting objections from the general public.

Whereas objections received from the general public were considered by the Government in consultation with The Punjab Regional and Town Planning and Development Board in its 38th meeting held on 19.06.2019 and the Board approved the Master Plan, Dasuya in the said meeting.

Now, therefore in exercise of powers conferred under Section 70 (5) of "The Punjab Regional and Town Planning and Development Act, 1995", the Master Plan, Dasuya comprising of written report along with drawings i.e., Existing Landuse Plan-2012 Drawing No. D.T.P (H) 164/2012 dated 30/08/2012 and Proposed Landuse Plan (2012-2031) Drawing No. D.T.P (H) 46/2019 dated 15/07/2019 are hereby notified.

It shall come into operation from the date of its notification.

This issues with the approval of the Government vide Memo no.12/08/2019-4HG1/949 dated 25/06/2020.
