The Government of Punjab intend to promote urban growth of Sri Anandpur Sahib Town of District Roopnagar and to provide for a workable frame work of this historical place and for its comprehensive planned and integrated development a special Development Authority is required to be set up. Therefore, The Governor of Punjab is pleased to define the boundaries of Sri Anandpur Sahib Urban Development Authority (SASUDA) consisting of 01 town and 23 villages covers, 5846 hectares (14440 Acres) area having population 27195 as per 2011 Census, under section-29 (1) of the "**The Punjab Regional and Town Planning and Development Act, 1995,**" and all other powers enabling him in this behalf. The schedule of boundary of SASUDA shall be as follows:-

Schedule of Boundary

North: Starting point from 'A' which is the common meeting point of Village Lang Majari (H.B no.310), Village Mangewal (H.B no 306) and Nangal- Sri Anandpur Sahib Road (NH 503), moving towards east along the northern- eastern boundary of Village Lang Majari (H.B.no. 310), northern boundary of Village Sadhewal (H.B.no.312), Village Banni (H.B.no.313), crossing Nangal Hydral canal and SYL canal, again moving along the northern boundary of Village Banni (H.B.no 313), Village Rampur (H.B.no.314) and Village Jhajar (H.B.no.315) upto point 'B', which is the common meeting point of Village Jhajar (H.B.no.315), Naina Devi-Sri Anandpur Sahib road (ODR-15) and common state boundary of Punjab and Himachal Pradesh.

East: Thence from point 'B' moving towards south along the eastern boundary of Village Jhajar (H.B.no.315), northern boundary of Village Tarapur (H.B.no.323), western-northern and eastern boundary of Village Mohiwal (H.B.no.324), eastern boundary of Village Tarapur (H.B.no.323), northern boundary of Village Dhanera (H.B.no.325), northern and eastern boundary of Village Lakher (H.B.no.326), crossing Massewal-Sri Anandpur Sahib road (ODR-16), again moving along the eastern boundary of Village Lakher (H.B.no 326), southern boundary of Village Jhinjri (H.B.no 365), crossing SYL canal and Nangal Hydral canal, again moving along the southern boundary of Village Jhinjri (H.B.no 365) upto point 'C' which is the common meeting point of Village Jhinjri (H.B.no 365) and Kiratpur Sahib-Sri Anandpur Sahib road (NH-503).

South: Thence from point 'C' moving towards west along the southern boundaries of Village Jhinjri (H.B.no.365), crossing Kiratpur Sahib-Sri Anandpur Sahib railway line, again moving along the southern boundaries of Village Jhinjri (H.B.no.365), Village Mataur (H.B.no.364), eastern boundary of Village Lodhipur (H.B.no.362), crossing Satluj river, again moving along the southern boundary of Village Lodhipur (H.B.no.362), southern boundary of Village Aggampur (H.B.no.360), crossing Satluj river, again moving along the southern-

western boundary of Village Aggampur (H.B.no. 360) upto point 'D', which is common meeting point of Village Aggampur (H.B.no. 360) and Jhajj Chowk -Sri Anandpur Sahib road (ODR-1).

West: Thence from point 'D' moving towards north along the western boundaries of Village Aggampur (H.B.no. 360), crossing Satluj river, again moving toward north along the western boundaries of Village Aggampur (H.B.no.360), Village Mahrauli (H.B.no.308), Village Chandesar (H.B.no.309), crossing Nangal-Sri Anandpur Sahib railway line, then again moving along the western-northern boundary of Village Chandesar (H.B.no.309), Village Lang Majari (H.B.No 310) upto point 'A' which is the starting point.

The boundary of Sri Anandpur Sahib Urban Development Authority (SASUDA) are shown on the drawing no: 02/2019 DTP(R), dated: 08.02.2019.
